SECTION 3 HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW – Thin viscosity liquid with mild ketonic solvent odor. Warning! Flammable liquid and vapor. Keep away from heat sparks and flames. May cause eye, skin and respiratory tract irritation. If swallowed do not induce vomiting. Get immediate medical attention.

POTENTIAL HEALTH EFFECTS

Eyes: Liquid is moderately irritating to the eyes. **Skin:** Liquid is mildly irritating to the skin.

Ingestion: Ingestion of liquid may cause vomiting.

Extinguishing Media -

Use water fog, foam, dry chemical or CO2. Use water spray to cool fire-exposed containers and to protect personnel.

Special Fire Fighting Procedures -

Keep containers cool and vapors down with water spray. Prevent spill from entering drains, sewers, streams or other bodies of water. If run-off occurs, notify proper authorities. Do not enter confined fire space without full bunker gear (helmet with face shield, bunker coats, gloves and rubber boots); including a positive pressure NIOSH approved self-contained breathing apparatus.

Unusual Fire and Explosion Hazards – Vapors are heavier than air and may travel along ground, or be moved by ventilation and be ignited by ignition source.

SECTION 6 ACCIDENTAL RELEASE MEASURES

SECTION 7 HANDLING AND STORAGE

HANDLING: Empty containers retain residue (liquid and/or vapor) and can be dangerous.
